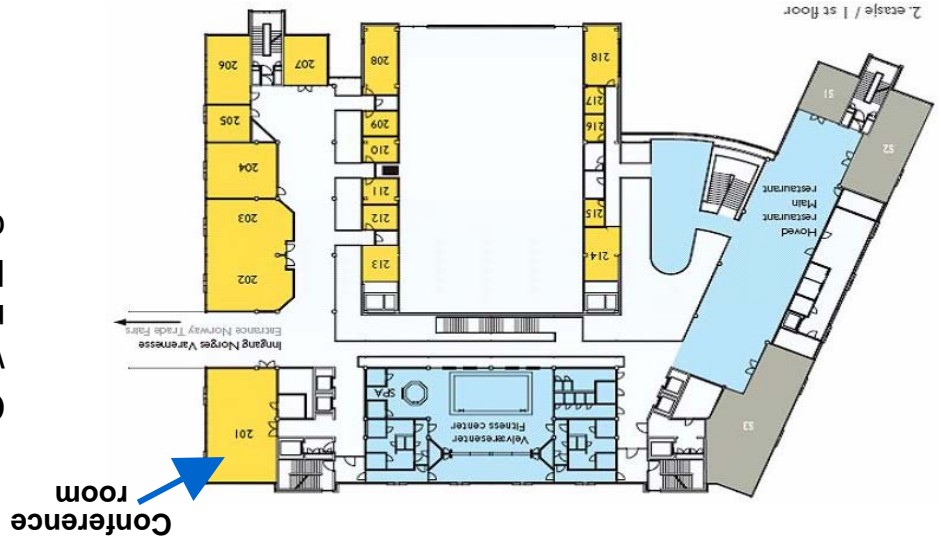

## Future Marine Fuels – Challenges to the Marine Industry

The current requirements of MARPOL Annex VI to limit SO<sub>2</sub>-emissions in the Sulphur Emission Control Areas (SECAs) will have an impact on both the supply of fuel oils as well as the operation of ships in the SECAs. The current Annex VI is now being revised and different proposals have been put forward, including a proposal to require ships only to use distillate fuels. The proposals will not only affect fuel qualities and specifications and thus engine operation, but will also have more far reaching implications for ship systems as well as for the refining industry. The CIMAC Circle panel will address all key issues related to these new proposals, including the current status of the IMO process, the merits of the various proposals including their implications for engine operation and the future supply of fuel oil to the shipping industry.
